Sarajevo, June 26th - 27th of 2014

A total of 199 complaints regarding the writings of the press and online media received

The Complaints Commission of the Press Council in Bosnia and Herzegovina, during the 26th and 27th

of June of 2014, held its fifty ninth session, where it considered complaints regarding the writings of the press and online media received in the period from April to June 2014. The Press Council in BiH received a total of 199 complaints, out of which 21 were considered at the session.

The Complaints Commission upheld 13 complaints, where a breach of the Press Code of BiH was found. 8 complaints were not upheld, because there were no violations of the Press Code of BiH.

147 complaints were resolved through self-regulation, i.e. by the publication of denials, reactions, corrections or apologies, or by removing comments that contain hate speech, discrimination or incitement from portals. 5 complaints were outside of the Press Council's jurisdiction, being that they regarded content published on social networks, electronic media or internet blogs. 11 complaints were not sent on time, while 1 complaint was filed as *ad acta*. 14 complaints were being processed at the time of the session.

Complaints Upheld:

Complaint upheld: The Complaints Commission found breach of Article 2 - Editorial Responsibility, Article 3 - Incitement, Article 4 - Discrimination, Article 4a - Gender Equality and Respect for Individuality, and Article 6 - Comment, Assumption and Fact, of the Press Code of BiH.

3. Ms. SEVIMA SALI-TERZIĆ – portal **AVAZ.BA**: Reaction to statements from the article “Horrible: They are hiding hundreds of Flood Victims in Doboj?” from 22.05.2014. The Complaints Commission found breach of Article 1 - Public Interest, Article 2 - Editorial Responsibility, and Article 5 - Accuracy and Fair Reporting, of the Press Code of BiH.
