

## **66<sup>th</sup> SESSION OF THE COMPLAINTS COMMISSION OF THE PRESS COUNCIL IN BIH**

**January 14<sup>th</sup> 2015**

The Complaints Commission of the Press Council in Bosnia and Herzegovina will hold its sixty-sixth session on Thursday, January 14<sup>th</sup> 2016, during which it will consider thirty (30) complaints, received in the period October 2015 - January 2016. During this same period, the Press Council in BiH also received forty-seven (47) complaints that were resolved through self-regulation, i.e. through the publication of denials, reactions, corrections or apologies, or through removal of comments containing hate speech, incitement or discrimination.
